# 4.1 Description of first aid measures

- **6.3 Methods and materials for containment and cleaning up:** Cover spillage with suitable absorbent material. Using non-spark tools, sweep up material and place in an appropriate container. #### **SECTION 7 - HANDLING AND STORAGE**
