SECTION 3- COMPOSITION/INFORMATION ON INGREDIENTS

Composition: Mixture of 10 mM Tris Base, 1 mM EDTA Disodium Dihydrate, pH 8.0 ± 0.2 . Prepared in 18.2 megohms-cm ± 1 water and autoclaved at 15 psi (121° C) for 30 minutes on liquid cycle and/or filtered through 0.22-micron filter.

SECTION 4 - FIRST-AID MEASURES

4.1 Description of first aid measures
