4.1 Description of first aid measures

- **6.3 Methods and materials for containment and cleaning up:** Cover spillage with suitable absorbent material. Using non-spark tools, sweep up material and place it in an appropriate container. Decontaminate spill site with 10% caustic solution and ventilate area until after disposal is complete. Hold all material for appropriate disposal as described under section 13 of SDS.

SECTION 7 - HANDLING AND STORAGE

- **7.1 Precautions for safe handling:** Use in a chemical fume hood, with air supplied by an independent system. Avoid inhalation, contact with eyes, skin and clothing. Avoid the formation of dust and aerosols. Use in a well-ventilated area. Keep away from sources of ignition. Avoid prolonged or repeated exposure.
- **7.2 Conditions for safe storage, including any incompatibilities:** Store in cool, well-ventilated area. Keep away from direct sunlight. Keep container tightly sealed until ready for use. Keep in a dry place. Moisture sensitive. Hydroscopic.
