#### **4.1 Description of first aid measures**

## **SECTION 6 - ACCIDENTAL RELEASE MEASURES**

Avoid the formation of dust and aerosols. Use in a well-ventilated area. Keep away from sources of ignition. Avoid prolonged or repeated exposure.

**7.2 Conditions for safe storage, including any incompatibilities:** Store in cool, well-ventilated area. Keep away from direct sunlight. Keep container tightly sealed until ready for use. Store at room temperature.
